GENERAL & COVID19 DISCLAIMERS & INFORMED CONSENT FOR PROGRAMS & ACTIVITIES

Please read carefully prior to signing:

GENERAL RELEASE

I understand there are risks of physical injury in participating in sports and recreational activities or programs.

I hereby release the Town of Seymour, its employees, officials and agents from any and all liability or loss or damage to personal property that, my child or I may experience in connection with activities sponsored by Seymour Community Services, Seymour Recreation, and Seymour Senior Center.

I hereby consent to emergency medical procedures deemed advisable for me, or my child in the event I cannot be reached and my child has sustained an injury. The department does not provide accident or hospitalization insurance for participants of its programs. All participants are advised to have adequate personal coverage. Please consider participant's own health, experience, and tolerance for risk before participating in any program.

Requests for a program refund should be directed to the Community Services Director. Trip Refunds will only be given if tickets have not been purchased. A full account credit or a refund less an administrative fee will be given if withdrawal notification is received 7 days prior to the session start date. If a participant is forced to leave after the start of a session due to injury or illness, a prorated refund may be given at the at the Director's discretion.

In addition to the above, I hereby assign and grant to the Town of Seymour, Seymour Community Services, Seymour Recreation Commission and the Seymour Commission on Aging the right and permission to use and publish the photographs or videos made of me or my child(ren) at any and all activity or program, and any artwork that we may create, and release the Town of Seymour, Seymour Community Services, Seymour Recreation Commission, Seymour Commission on Aging their employees, officials, and agents from any and all claims or liability arising out of the foregoing.

ASSUMPTION OF RISK & WAIVER OF LIABILITY RELATING TO COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The Seymour Recreation Department has put in place preventative measures to reduce the spread of COVID-19; however, we cannot guarantee that you, your household members, or your child(ren) will

not become infected with COVID-19. Further, attending Seymour Recreation Department programs could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren), household members, and I may be exposed to or infected by COVID-19 by attending Seymour Recreation Department programs and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Seymour Recreation Department programs may result from the actions, omissions, or negligence of myself and others, including, but not limited to, employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for and injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at or participation in Seymour Recreation Department programs. On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless the Town of Seymour and Seymour Recreation Department, their employees, officials, agents, and representatives, of and from any claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the Seymour Recreation Department programs, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in the Seymour Recreation Department programs.

INFORMED CONSENT

I also hereby attest that I have been informed of the following pertaining to the coronavirus:

People who are 65 years and older and people of any age who have serious underlying medical conditions or are at higher risk for severe illness from COVID-19 are recommended to stay at home. A list of medical conditions associated with a higher risk for severe illness from COVID-19 can be found in CDC's guidance. Individuals and families should consult their healthcare provider to determine whether they have medical conditions that place them at risk.

Adults and children living in households with individuals who are 65 years and older OR have higher risk for severe illness from COVID-19 are recommended to stay home.
